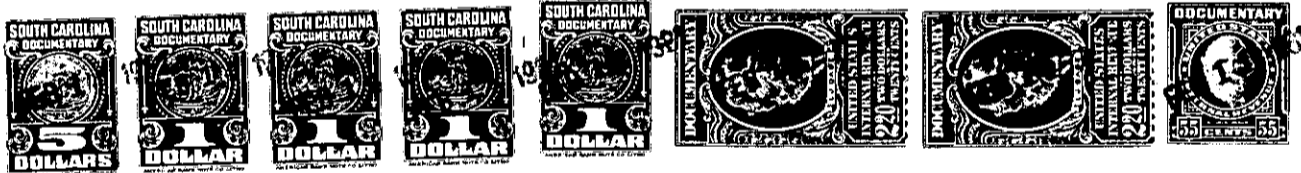
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

All that lot of land in the County of Greenville, State of South Carolina, in Butler Township; containing 11.75 acres, more or less, and being a portion of the property of Rebecca Ray Henderson Estate, and having the following metes and bounds, to-wit:

Beginning at an iron pin in Miller Road at the corner of property of W. Milton and Doris H. Poling, (which was conveyed to them by the grantor) and running thence along said property, N 60-30 W, 510 feet to an iron pin; thence along property of Truman and Mamie S. Garrett, S 35 W, 701.8 feet to an iron pin; thence along property of Pope Miller, S 59 E, 780 feet to an iron pin; thence around the lot sold by the grantor to W. H.
