Wallace Cely., his heirs and assigns, All that piece, parcel or lot of land in Butler Township, Greenville County, South Carolina, about 4 miles East of Greenville County Court House, on the southern side of a County Road, a top-soil road leading westerly off the Congaree Road and having the following metes and bounds, to wit: Beginning at a point, joint front corner with lot conveyed by Garrett Ferguson to William A. Norris and Mary Lou Norris, said point being 108.9 feet easterly from an easement for an existing road and running thence S. 25-13 E 200 feet to a point, joint rear corner with Norris lot in line of other property of Garrett Ferguson; thence N 64-47 E 108.9 feet along line of said last mentioned property to point; thence N.25-13 W 200 feet, cont& inuing along line of other property of Garrett Ferguson, to point on southern side of said County Road; thence along southern side of said County Road, S-64-47 W. LO8.9 feet to the point of beginning and containing 1/2 of an acre, more or less.
