Orla F. Nielssen and Fern E. Nielssen, their heirs and assigns forever:

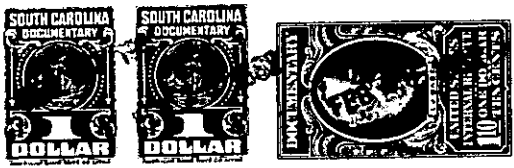
