to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said W. C. Hendrix, his heirs and assigns forever:

All that piece, parcel or lot of land being known and designated as Lot 112 on Charles Drive in a subdivision known as Pine Forest as shown by a plat thereof made by Madison H. Woodward, Engineer, said lot having the following metes and bounds, to-wit:

Beginning at an iron pin on the west side of Charles Drive and running thence N. 20-30 E. 60 feet to an iron pin on Charles Drive, joint front corner of Lots 112 and 113; thence along the line of Lots 112 and 113, N.72-06 W. 418.8 feet to an iron pin on the east side of West Pine Lake Circle, joint corner of Lots 113 and 112; thence along said West Pine Lake Circle S. 20-13 W. 60 feet to an iron pin on West Pine Lake Circle, joint corner of Lots 112 and 111-A; thence along the line of Lots 111-A, 111, 110-B, 110-A and 110, 377.5 feet to an iron pin on the west side of Charles Drive, the point of beginning.

Also, all that certain piece, parcel or lot of land in Gantt Township, Greenville County, South Carolina, being known and designated as the northwest half of Lot 113 "Conestee Plat 2", made by Madison H. Woodward, Engineer, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book T, at Pages 383-4, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southeastern side of West Pine Lake Circle at the joint corner of Lots 112 and 113 and running thence along the joint line of said lots, S. 72-06 E. 218.8 feet to an iron pin; thence through Lot 113 to an iron pin on Lot 114; thence along the line of Lot 114, N. 72-06 W. 215.9 feet to an iron pin on the southeast side of West Pine Lake Circle; running thence along said street S. 20-13 W. 70.5 feet to iron pin, the point of beginning.
