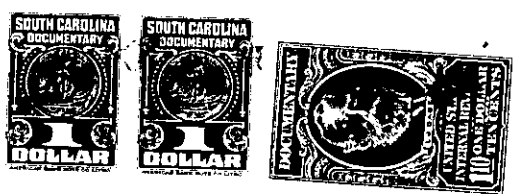
This lot is sold subject to any and all restrictions now recorded against this lot in the R. M. C. Office for Greenville County, South Carolina (see Record).

This is the same lot # 7 as was conveyed to me by H. H. Willis and Alice M. Willis by their deed dated 17 March, 1943, and recorded in the R. M. C. Office for Greenville County in Deed Book 252 at page 179.
