ALL those pieces, parcels or lots of land, situated on the South side of Riverview Circle, in Greenville County, Greenville Township, near the City of Greenville, South Carolina, shown as Lots 6 and 7 on Plat of Map No. 2 of Riverdale Subdivision, made by Dalton & Neves, Engineers, June, 1958, recorded in the RMC Office for Greenville County, S. BEGINNING at an iron pin on the South side of Riverview Circle, at the joint front corner of Lots 5 and 6, and running thence with the line of Lot 5, S. 9-21 W., 264 feet to an iron pin at the high water mark of the Saluda River; thence with the high water mark of the Saluda River, N. 72-12 E., 198.5 feet to an iron pin on the high water mark of the Saluda River; joint rear line of Lots 6 and 7; thence continuing with the high water mark of the Saluda River, N. 48-41 E., 141.1 feet to an iron pin at the joint rear corner of Lots 7 and 8; thence with the joint line of said lots, N. 32-34 W., 186 feet to an iron pin on the South side of Riverview Circle; thence with Riverview Circle, S. 54-0 W., 38.7 feet to an iron pin; thence with the curve of Riverview Circle (the chord being S. 62-34 W., 46.3 feet) to an iron pin at the joint front line of Lots 6 and 7; thence continuing with the curve of Riverview Circle (the chord being S. 85-52 W., 80 feet) to the point of beginning.
