



BEGINNING at an iron pin on the eastern side of Paris View Drive (formerly Fairview Avenue), the joint front corner of lots # 25 and #26, and running thence along the line of these lots N. 48-20 E. 131.2 feet to an iron pin in the line of Lot No. 27; thence along the joint line of Lots Nos 25 & 27, N. 73-08 W., 124.8 feet to an iron pin on the eastern side of Paris View Drive, running thence along the eastern side of Paris View which line is curved, the chord of which is, the following courses and distances, to-wit: S. 11-55 W. 22 feet to an iron pin; thence S. 2-33 E. 50 feet to an iron pin; thence S. 22-33 E. 50 feet to an iron pin, point of beginning.
