the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Frances P. Hightower,

All that lot of land in the county of Greenville, state of South Carolina, containing 2.30 acres, being known and designated as Lot No. 3 on plat recorded in the RMC Office for Greenville County in plat book WW page 243, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the southwest side of Phillips Road, the joint corner of Lots Nos. 3 & 4; thence with the southwest side of said Road N. 24-45 W. 185 feet to an iron pin corner of Lot No. 2; thence with the line of said Lot S. 63-40 W. 551.8 feet to an iron pin on the northeast side of the right of way of Poinsett Highway; thence with the northeast side of said Highway, S. 26-40 E. 180 feet to an iron pin corner of Lot No. 4; thence with the line of said lot N. 64-11 E. 544 feet to the beginning corner.

This is a portion of the property devised to the grantor by Hattie Marchbanks Phillips by her will on file in the Probate Court for Greenville County in Apartment 720 file 8.

This lot is conveyed subject to building restrictions applicable to the lots on said plat recorded in deed volume 698 page 495.

TOGETHER with the right to the use of Phillips Road shown on the above mentioned plat for ingress and egress to the above described lot, which easement and right of way shall be a covenant running with the land.

In addition to the restrictive covenants recorded in deed vol. 698 page 495 referred to above, no alcoholic beverages shall ever be sold or stored on this lot of land.
