All that certain piece, parcel or lot of land in the County of Greenville, South Carolina, being shown and designated as lot no. 107, Thornwood Acres Subdivision, Section no. 2, on plat by J Mac Richardson, Engineer, dated April, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "MM" at page 105 and having, according to a more recent survey by Dalton and Neves, Engineers, March, 1960 the following metesand bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of Merrywood Drive at the joint front corner of lots nos. 106 and 107, and running thence with the joint line of said lots, N 23-44 W., 192 feet to an iron pin in line of lot no.38; thence N. 53-13 E., 31 feet to an iron pin; running thence N. 52-01 E., 50 feet to an iron pin at the joint rear corner of lots nos.107 and 108; running thence S. 25-24 E., 215.2 feet to an iron pin on the Northerly side of Merrywood Drive; running thence along the Northerly side of Merrywood Drive; which line is curved, and the chord of which is S. 68-13 W., 56 feet to an iron pin; thence continuing with the Northerly side of Merrywood Drive, S. 70-30 W., 29 Feet to an iron pin, the point of beginning.

As a part of the consideration the grantee assumes and agrees to pay the balance on that certain mortgage from the grantor to C. Douglas Wilson, Company, mortgage being recorded in the R.M.C.
