Dempsey Window Co., Inc., its successors and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as lot No. 25 on a plat of Shamrock Acres recorded in the R.M.C. Office for Greenville County in Plat Book YY at Page 43 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Shamrock Circle at the joint front corner of Lots 24 and 25 and running thence with the westerly side of Shamrock Circle N. 32-44 W. 100 feet to an iron pin; thence around the curve of the intersection of Shamrock Circle and Kingswood Drive, the chord of which is N. 88-52 W., 22.3 feet to an iron pin on the southeasterly side of Kingswood Drive; thence with said Drive S. 35-00 W. 173.2 feet to an iron pin; thence S. 33-30 E. 55 feet, more or less, to an iron pin, the joint rear corner of Lots 24 and 25; thence with the common line of said lots N. 57-16 E. 159.6 feet to the point of beginning.

The above lot is conveyed subject to the recorded restrictions applicable to Shamrock Acres and to the set-back line as shown on said plat.
