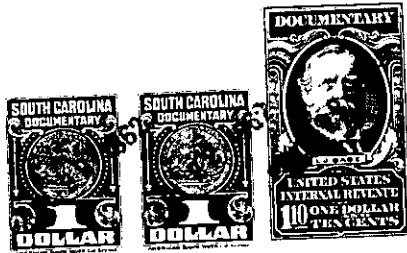

Office for Greenville County in Plat Book BB, at Page 27, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Harvard Drive, joint front corners of Lots Nos. 57 and 58 and running thence along the line of said lots, N. 2-15 E. 165 feet to iron pin rear corner of Lots 77 and 78; thence running with rear line of Lot 77, N. 87-45 W. 100 feet to iron pin rear corner of Lot 59; thence running with line of said lot, S. 2-15 W. 165 feet to iron pin on Harvard Drive; thence running with Harvard Drive, S. 87-30 E. 100 feet to iron pin at point of beginning.

NO residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on said lots; no residence shall be erected on any lot nearer than 35 feet to the front line; no residence shall be erected on any lot unless said lot has fifty (50) feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.
