All that certain piece, parcel or lot of land, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 66 as shown on a plat prepared by J. Mac Richardson, R.L.S., dated December, 1959, entitled "Final Plat, Part of Section Two, Orchard Acres", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book MM at page 147, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Fairhaven Drive at the joint front corner of Lots Nos. 66 and 67, and running thence with the line of Lot No. 67 S. 80-44 W. 178.3 feet to an iron pin; thence N. 11-13 E. 64.8 feet to an iron pin; thence with the line of Lot No. 65 N. 1-50 W. 40 feet to an iron pin at the joint rear corner of Lots Nos. 64 and 66; thence with the line of Lot No. 64 N. 84-44 E. 159.7 feet to an iron pin on the Western side of Fairhaven Drive; thence with the Western side of Fairhaven Drive and following the curve thereof, the chord of which is S. 3-38 E. 90 feet, to the point of beginning.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

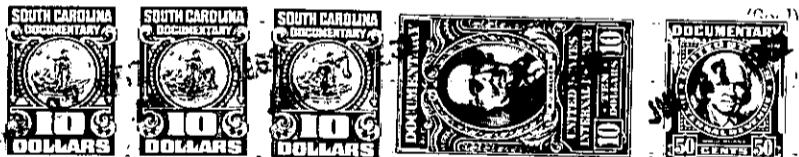
