HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto
the said **E. L. Mayfield and Hazel B. Mayfield**

All that certain lot of land situated in Chick Springs Township,
County and State aforesaid, being known and designated as lot No. 20
in what is known as Lake View Heights, property of Mrs. Bessie and
I. M. Wood Estate as shown on a subdivision and plat of same made by
H. S. Brockman, Reg. Surveyor, dated November 2, 1959, said plat
being of record in the R. M. C. Office for Greenville County in Plat
Book RR, page 19 and having the following metes and bounds and courses
and distances as shown by said plat, to-wit:

BEGINNING at an iron pin in the Northern boundary of Woodfield
Drive, joint front corner of lots 19 and 20, and running thence
N. 74-05 E. 124 feet to an iron pin; thence N. 27-39 E. 89 feet to an
iron pin in line of Roscoe Drive; thence along the Western boundary
