to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto CARRIE EVALENA ROSEMOND WILLIAMS, HER HEIRS AND ASSIGNS FOREVER:

ALL OUR RIGHT, TITLE AND INTEREST, THE SAME BEING AN UNDIVIDED INTEREST, OF, IN AND TO,

ALL THAT PIECE, PARCEL OR LOT OF LAND SITUATE, LYING AND BEING IN GANTT TOWNSHIP, GREENVILLE COUNTY, SOUTH CAROLINA, ON THE NORTHERN SIDE OF FAIRFIELD ROAD AND BEING KNOWN AND DESIGNATED AS LOT 1 ON A PLAT OF "PROPERTY OF EDWARD & MARTHA ROSEMOND ESTATE" DATED SEPTEMBER 1959 PREPARED BY C.
