All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, near the corporate limits of the Town of Greer, on the southern side of National Highway, formerly, now Emma Street, adjoining lands now or formerly of I. F. Reese and others, and described as follows:

BEGINNING at an iron pin on the southern side of National Highway (now Poinsett Street), at the corner of property now or formerly owned by W. P.
