(\$11,150.00) in the State aforesaid,

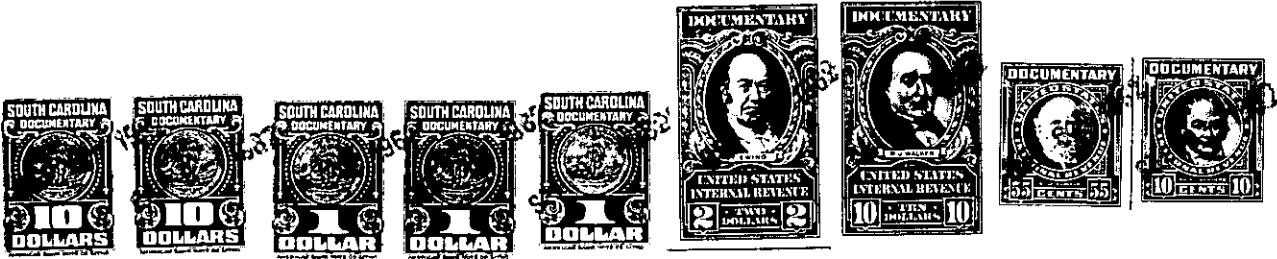
in consideration of the sum of Eleven Thousand One Hundred Fifty and no/100-----DOLLARS,

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 38 on a plat of Shamrock Acres, recorded in the R.M.C. Office for Greenville County in Plat Book YY, Page 43 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Shamrock Circle at the joint front corner of lots 38 & 39 and running thence with the common line of said lots N. 8-42 E. 148.6 feet to an iron pin; thence N. 81-57 E. 110.3 feet to an iron pin on the western side of Shamrock Circle; thence with said street S. 8-03 E. 113 feet to an iron pin; thence around a curve in said street, the chord of which is S. 18-20 W. 50 feet to an iron pin; thence continuing with the curve of said street, the chord of which is S. 72-17 W. 50.2 feet to an iron pin; thence continuing with said street N. 81-18 W. 85 feet to the point of beginning.
