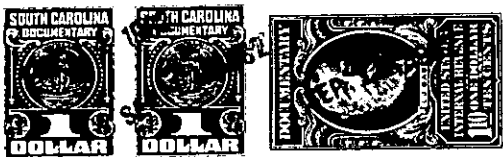
KNOW ALL MEN BY THESE PRESENTS, that I, Margaret W. Chapman

and assumption of mortgage as set out below
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Mrs. Rose P. Brooks, Her Heirs and Assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, being known and designated as Lot No. 4 of the property of Talmer Cordell, according to a plat thereon prepared by Dalton & Neves, Engineers in November, 1950 and recorded in the RMC Office for Greenville County in Plat Book Z at page 113, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the west side of McClain Avenue at the joint front corner of Lots 3 and 4 and running thence along the west side of McClain Avenue, S. 14-58 E. 55 feet to an iron pin at the corner of Lot No. 5; thence along the line of that lot, S. 76 W. 151.8 feet to an iron pin; thence N. 14-00 W. 55 feet to an iron pin at the rear corner of Lot No. 3; thence along the line of that lot, N. 76 E. 150.8 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agree to be part of the realty. This being the same property conveyed to grantor by deed of Edwin E. & Dorothy G. Reeves recorded October 3, 1961 in Deed Book 683 page 234.

The grantee agrees to assume and pay, according to its terms that certain note and mortgage given to General Mortgage Co. on which there is a balance due of \$9,562.30; said mortgage is recorded in Mortgage Book 867, page 437.
