said Hunt Foods & Industries, Incorporated has required as a condition before which said Subordination Agreement will be signed that said Herman F. Dill and Meta S. Dill agree to apply the proceeds of any minerals which are extracted from said premises to the outstanding balance due on the said mortgage of First Federal Savings and Loan Association of Greenville.

NOW, THEREFORE, in consideration of the premises and the Subordination Agreement of Hunt Foods & Industries, Incorporated subordinating all of its rights and reservation of mineral rights in the property hereinafter described in favor of said mortgage to First Federal Savings and Loan Association of Greenville, S.
