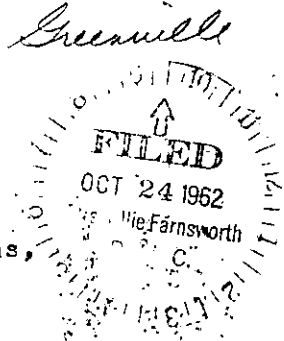
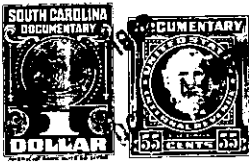

KNOW ALL MEN BY THESE PRESENTS, that We, Rufus B. Atkins and Louise G. Atkins,

in consideration of One Hundred Fifty and No/100 ----- Dollars,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Samuel B. Wasson and Ida E. Wasson, their Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Butler Township, about one mile south of Batesville, S. C., lying on the north side of the Griffith Road, being shown as Lot No. 2 on a plat of Property of Samuel B. & Ida E. Wasson, made by H. S. Brockman Surveyor, April 23rd 1962, and being a part of the same property conveyed to us by deed from J. Wayman Smith January 14th 1953, recorded in the office of the R. M. C. for Greenville County in Deed Book 470 at page 171, and having the following courses and distances, to wit:-

Beginning on a nail and cap in the center of the said Griffith Road, at a point S. 65-30 W. 193 feet from the corner of the lot formerly owned by Bragg, and being the joint corner of Lots Nos. 1 and 2 as shown on said plat, and runs thence with the common line of Lots Nos. 1 and 2, N. 24-59 W. 20 feet to an iron pin on the northern bank of the said road, then continuing with the same course for a total distance of 283.6 feet to an iron pin across a Spring branch; thence S. 65-30 W. 237.6 feet to an iron pin; thence S. 24-30 E. 183.6 feet to a nail and cap in the center of the said road (iron pin back on line at 24.3 feet); thence with the said road N. 65-30 E. 239.7 feet to the beginning corner, containing One and One-half (1.5) acres, more or less.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s) heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
