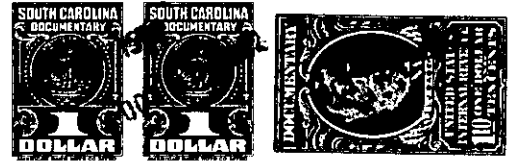

 in consideration of the sum of One Thousand (\$1000.00) in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) L.F.Few and T.I.Forrester, their heirs and assigns forever:

All of that parcel or tract of land in Glassy Mountain Township of Greenville County, South Carolina, bounded by lands now or formerly owned by Ora Turner, Ollie P.Hughes, Selma P.Good, Elsie H.Pittman, George Pittman and others, containing Thirty-eight(38) acres, more or less, and having the following courses and distances as shown on plat thereof made by J.Q. Bruce, Surveyor, dated July 22, 1959, to wit:  
 BEGINNING on a blackgum (old) near rock cliffs, called "sheep rock" and runs thence with Ora Turner's line S. 8 W. 468 feet to a large pine; thence S. 5 W. 1395 feet to a stone; thence S. 47-35 W. 673 feet to a point in road; thence along road as follows: S. 57 E. 82 feet, S.85 E. 236 feet and S. 39 E. 141 feet to intersection of road with branch; thence up the branch as the line(mapping line being N. 32-30 W. 187 feet) to a sweet gum and iron pin; thence S. 51 E. 878 feet to an iron pin; thence N. 5-30 W. 397 feet to an iron pin; thence N. 47 W. 594 feet to a point in branch by large rock(old mark); thence up the branch as the line to a spring on the Ollie P. Hughes line; thence N. 1/2 W. 858 feet to a locust stake; thence N. 7 E. 785 feet to a stone; thence about north to a locust stump (old corner) on the Means line; thence with the Means line S. 67-45 W. 732 feet to the beginning corner, and being all of that tract of land as described in deed to grantor from Haskell Pittman, et al, dated June 8, 1959, recorded in the R.M.C. Office for Greenville County in Deed Book 628, at page 398.
