Conditions That Are Agreed to by the Applicant in Consideration of and As a Precedent to the Issuance of This PERMIT.

- (a) The estimated or calculated service charge from the date Service is begun to June 30th next following this date and paid at the time of the issuance of this PERMIT is \$ _____
- (b) To pay for said service in advance at the office of the Commission not later than the 30th of June of each year a service charge to be computed by the Commission and billed to the designated person or firm on or before June 10th of each year, which charge shall be based on the assessed value of the property served and multiplied by one and one-half (1½) times the rate of the tax or special levy imposed by the Commission upon property located within Greater Greenville Sewer District; or, a charge which shall be equal to fifty percent (50%) of the amount paid or to be paid for water used or consumed on the premises served during the last preceding twelve months, whichever is the greater. In any event, however, the minimum annual charge shall be no less than \$100.00. If, however, this charge is not paid within thirty (30) days of its billing date, a penalty of five percent (5%) of said charge shall be added for each month of delinquency.
- (c) To notify the Commission immediately upon the vacation or sale of the within described property with the name and address of the new tenant or owner.
