

Faress

ALL those pieces, parcels or lots of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the northern side of Ridge Drive (now Byrd Boulevard) and being known and designated as Lots Nos. 180 and 181 of Marshall Forest, as shown on plat thereof prepared by Dalton & Neves, October 1928, and recorded in the R.M.C. Office for Greenville County in Plat Book "H", at page 133, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Ridge Drive (now Byrd Boulevard) at joint corner of Lot No. 180 and a ten-foot strip reserved for pipes and poles, and running thence along said strip, N. 66-12 E. 359.5 feet to an iron pin; thence N. 39-22 W. 52.6 feet to an iron pin, joint rear corner of Lots Nos. 181 and 182; thence along the joint line of said lots, S. 66-12 W. 349.5 feet to an iron pin on Ridge Drive (now Byrd Boulevard); thence along said drive, S. 28-18 E. 50.3 feet to the point of beginning.

Being the same property conveyed to the grantor herein by deed of Joe J. Faress dated March 31, 1960 and recorded on April 12, 1960, in the office of the R.M.C. for Greenville County in Deed Book 648, at page 148.
