

CRAMAX REMARK ERAMACA AND XX

ALL that piece, parcel or lot of land in Greenville County, South Carolina, on the southern side of Greenwood Avenue, known and designated as Lot fifty-two (52) on a plat of Hudson Acres, recorded in the RMC Office for Greenville County in Plat Book "Y" at page 39, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southern side of Greenwood Avenue at the corner of Lot 51 and running thence with the southern side of Greenwood Avenue the following courses and distances: N. 71 - 00 W. 100.0 feet, N. 63 - 30 W. 37.5 feet, N. 55 - 45 W. 37.5 feet, and N. 49 - 00 W. 20.9 feet, to an iron pin at the corner of Lot 53; thence with Lot 53 S. 29 - 50 W. 200.8 feet to an iron pin at the rear corner of Lot 49; thence with Lot 49 S. 79 - 30 E. 209.5 feet to an iron pin at the rear corner of Lot 51; thence with Lot 51 N. 29 - 50 E. 145.0 feet to the beginning corner.

The grantees, as part of the consideration of this deed, assume payment of a mortgage originally given to C. Douglas Wilson & Co., Ly William P. Loftis, recorded in the RMC Office for Greenville County in Mortgage Book 863 at page 435, and having a balance as of October 1, 1962 of \$14,516.90, together with the interest from that date to the date of this conveyance.
