sum of Eighteen Hundred Fifty and No/100 (\$1850.00)----- dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto DONALD E. BALTZ:

All that piece, parcel or lot of land situate, lying and being on the Southern side of Vicki Circle near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 34; as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R.L.S., in January, 1959, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the southern side of Vicki Circle at the joint corner of Lots 34 and 35 and running thence along the southern side of Vicki Circle S. 85-29 E. to a concrete monument, thence continuing along the curve of Vicki Circle S. 79-27 E. 25 feet to an iron pin, the joint front corner with Lot 33, thence along the line of Lot 33 S. 26-35 W. 252 feet to an iron pin, thence N. 77-58 W. 44.6 feet to an iron pin, thence along the line of Lot 35 N. 4-31 E. 230.4 feet to an iron pin on the southern side of Vicki Circle, the point of beginning.

The premises herein described are subject to a drainage easement along its rear line, as shown on the plat referred to above.

This is a portion of the property conveyed to the grantor herein by deed of Lucile L. Smith, et al, dated September 15, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 634 at page 188.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
