to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. G. Griffen, his heirs and assigns forever:

All that lot of land in Cleveland Township, Greenville County, State of South Carolina, being known and designated as Lot No. 8 of Section One of Silver Shoals, recorded in the RMC Office for Greenville County in Plat Book MM at Page 35, and described as follows:

BEGINNING at an iron pin on the Southern side of Shoaks Drive at the corner of Lot No. 7 and running thence with the Southern side of said drive, S.65-41 E. 100 feet to an iron pin at the corner of Lot No. 9; thence with the line of said lot, S. 9-24 E. 206.9 feet to an iron pin on Silver Circle; thence with the Northern side of said Circle, N. 76-52 W. 92.4 feet to an iron pin at the corner of Lot No. 7; thence with the line of said lot, N. 9-47 W. 228.8 feet to the beginning corner.

It is understood that this lot is conveyed subject to the building code of Silver Shoals and shall become a part of the water district of Silver Shoals

It is understood that the grantees shall have access and privilege of the use of the Middle Baluda River, together with the other property owners purchasing other lots from the grantor, with the exception of the river front area immediately in front of Lot 33 and west therefrom which is expressly reserved to the grantor.

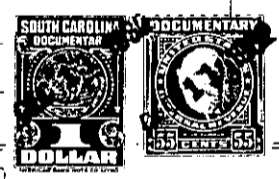
