All that certain piece, parcel or Lot of land, situate, lying and being in the State of South Carolina, County of Greenville and in Butler Township, on the Western side of Richbourg Road and being shown and designated as Lot Number Seven on a Revision of Lots 5,6, and 7 of the Plat of Extension of Morningside Subdivision recorded in Plat Book FF at page in the R.M.C.Office; said lot of land being described according to the Revised Plat as follows, to wit:

BEGINNING at an iron pin on the Western side of Richbourg Road at the joint corner of Lots 6 and 7 of the said revised plat and running thence along the Western side of Richbourg Road North 25-05 West 147 feet to an iron pin; thence continuing along the Western side of Richbourg Road North 34-15 West 120 feet to an iron pin; thence continuing along said Richbourg Road 31 feet to the center line of the creek; thence, along the center line of the creek, South 67-20 West 188.5 feet to a point in center line of creek; thence South 22-40 Esst 22 feet, more or less to an iron pin; thence continuing along a line South 22-40 East 264.2 feet to an iron pin at the joint corner of Lots 6 and 7 on said Revised Plat; thence along the dividing line between said lots 6 and 7 North 67-23 East 218.84 feet to the place of beginning.
