All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, being known and designated as Lot No. 1 of Greenfields as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "XX", Page 103 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Mitchell Road at the joint front corner of Lots 1 and 2 and running thence along line of Lot No. 2 N. 72-10 E. 125.0 feet to an iron pin, joint corner of Lots 1, 2 and 17; thence along the line of Lot No. 17, N. 17-50 W. 125.0 feet to an iron pin on the southern side of Greenfield Drive; thence along Greenfield Drive S. 72-10 W. 100.0 feet to an iron pin at the corner of the intersection of Greenfield Drive and Mitchell Road; thence around the corner of said intersection and following the curvature thereof, the chord being S. 27-10 W. 35.3 feet, to an iron pin on the eastern side of Mitchell Road; thence along Mitchell Road S. 17-50 E. 100.0 feet to the beginning corner.
