

KNOW ALL MEN BY THESE PRESENTS, that I, Sampson, Smith, of Greenville County,

in consideration of One Hundred Fifty and No/100 - - - - - - - Dollars, and assumption of mortgage set out below the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Don L. Harvell and Jane K. Harvell, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 14, as shown on a plat of the property of Greenville Land Co., Inc., prepared by Piedmont Engineering Service, recorded in the R.M.C. Office for Greenville County in Plat Book RR, at Page 89, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Clemson Avenue, the joint front corner of Lots 14 and 15, and running thence along the line of these lots, S. 56-40 E. 141.6 feet to an iron pin; running thence S. 33-20 W. 70 feet to an iron pin at the joint rear corner of Lots 14 and 13; running thence N. 56-40 W. 143 feet to an iron pin on the southern side of Clemson Avenue; running thence along the southern side of Clemson Avenue, which line is curved, the chord of which is N. 34-30 E. 70 feet to an iron pin, point of beginning; being the same property conveyed to me by Leslie & Shaw, Inc. by deed dated June 25, 1962 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 701, page 56.

There is a 10-foot drainage easement along the rear line of Lot 14.

As a part of the consideration for this conveyance, the grantees expressly assume and agree to pay the balance due on that certain note and mortgage, in the original sum of \$7,800.00 executed by the grantor to the First Federal Savings and Loan Association of Greenville and recorded in the R.M.C. Office for Greenville County in Mortgage Book 894, at Page 69, the balance due thereon being the sum of \$7,747.03 as of this date.
