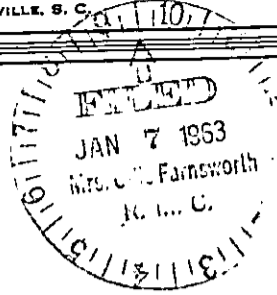

metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Southland Avenue at  
the joint front corner of Lots 2 and 3 and running thence along the  
joint line of said lots, N. 63-50 E. 200 feet to an iron pin in rear  
line of Lot 10; thence along the rear line of Lots 10, 11, 12 and 13,  
N. 26-10 W. 252.1 feet to a point, joint rear corner of Lots 1 and  
13; thence turning and running S. 63-24 W. 200 feet to a concrete  
monument on the easterly side of Southland Avenue; thence along the  
easterly side of Southland Avenue, S. 26-10 E. 250.8 feet to the point  
of beginning.

ALSO, AN UNDIVIDED ONE-THIRD (1/3) INTEREST IN AND TO: -

ALL that piece, parcel or lot of land situate at the intersection of  
the northerly side of Partridge Lane with the easterly side of Boxwood  
Lane, being shown on plat of property above referred to, recorded in  
Plat Book KK, Page 137, and having according to said plat the follow-  
ing metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Boxwood Lane in line  
of lot now or formerly of L. H. Pickens and Mary G. Pickens and  
running thence along the line of said lot, N. 60-54 E. 169.5 feet to  
an iron pin in line of property now or formerly of Dr. H. E. Riddle;  
thence turning and running along the line of said Riddle property,  
S. 35-46 E. 159 feet to an iron pin on the northerly side of Partridge  
Lane; thence along the northerly side of Partridge Lane, S. 63-24 W.
