in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Herman Kenneth Myer

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the east ~~XXXXXXXX~~ side of Augusta Road, and being Tracts Numbers 2 and 4, on Plat of the Estate of Herman S. Myer, made by C. O. Riddle, Engineer, November, 1962, and being recorded in the RMC Office for Greenville County, in Plat Book YY, page 99, and having the following metes and bounds, to-wit:

TRACT NO. 2

BEGINNING at an iron pin on the easterly side of Augusta Road, joint front corner Tracts 1 and 2; and running thence S. 89-02 E. 605.6 feet to an iron pin; thence S. 38-19 W. 67.1 feet to an iron pin; thence S. 37-50 W. 154.1 feet to a stone; thence S. 26-14 W. 203.8 feet to a stone in the line of Tract No. 3; thence N. 86-06 W. 462.5 feet to an iron pin on Augusta Road, joint front corner Tracts 2 and 3; thence along Augusta Road N. 13-47 E. 346.1 feet to an iron pin, the point of beginning, and containing 4.21 acres.

TRACT NO. 4

BEGINNING at an iron pin on the easterly side of Augusta Road, joint front corner Tracts 4 and 5; and running thence S. 84-48 E. 816.1 feet to an iron pin, joint rear corner Tracts 4 and 5; thence N. 6-05 E. 416.8 feet to an iron pin; thence N. 67-14 W. 18.4 feet to a point in the center of Bethuel Church Road; thence along the center of Bethuel Church Road as follows: S. 63-35 W. 326.2 feet to a point; thence S. 70-19 W. 100 feet to a point; thence S. 75-18 W. 100 feet to a point; thence S. 84-40 W. 100 feet to a point and N. 86-42 W. 208 feet to a point on Augusta Road; thence along Augusta Road S. 13-47 W. 252 feet to the point of beginning and containing 6.15 acres.
