

Beginning at a point on the northern side of Kathryan Circle, which point is the joint front corner of Lots Nos. 41 and 42, and running thence N. 2-05 W. 110 feet to a point; thence N. 42-55 E. 224 feet to a point in a creek; passing an iron pin located 15 feet from said creek; thence with the creek as the line, S. 13-04 E. 26.8 feet to a point in the creek; thence still with the creek as the line S. 70-32 E. 26.3 feet to a point, said point being the joint rear corner of lots Nos. 42 and 43; thence S. 30-02 W. 242.2 feet to a point on the northern side of Kathryan Circle; thence with the northern side of Kathryan Circle, S. 82-15 W. 40 feet to a point; thence still with the northern side of Kathryan Circle, S. 69-14 W. 27.3 feet to the point of beginning.
