to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lloyd H. Childers, as trustee

All my right, title and interest, if any I have, in and to: All that piece, parcel or lot of land in Grove Twnnship, Greenville County, South Carolina, being the same land left by Item 111 of the will of J. Addie Huff unto Agnes Lee Childers for the term of her natural life and at her death to the children of the said Agnes Lee Childers in fee. This parcel of land lies on the western side of the Fork Shoals Road and adjoins the lands of S. B. Huff and others and is the same as was conveyed to Lloyd H. Childers as trustee by the bodily heirs of the said Agnes Lee Childers by deed dated Nov. 26, 1960.

It is understood and agreed and made a part of this conveyance that the said Lloyd H. Childers, as trustee shall have the rights, powers and authorities therein and thereabouts as are fully set forth in the above mentioned deed dated Nov. 26, 1960, and executed by Hugh F. Childers, Lloyd H. Childers, Janie C. Jeter, Annie C. Goodwin, E. Paschal Childers, J. T. Childers, Mabel C. Ross, Robert L. Childers and Frances Childers to Lloyd H. Childers, trustee and also in another deed dated August 14, 1962, executed by Patricia C. Cason unto Lloyd H. Childers as trustee. The occasion for the execution of this instrument is the fact that Thos. J. Sullivan who was the father of J. Addie Huff willed all or a portion of the aforescribed tract of land unto his daughter, J. Addie Huff for the term of her natural life and at her death to her husband, if living, and if not to her bodily heirs. The said J. Addie Huff died in 1918, leaving a will dated Dec. 29, 1917, on file in the office of the Probate Court for Greenville County in Apt. 145, File 8.

The grantor hereof is a son of Mrs. Velona Garrison referred to in the will of J. Addie Huff as the deceased daughter of J. Addie Huff.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his successHeirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
