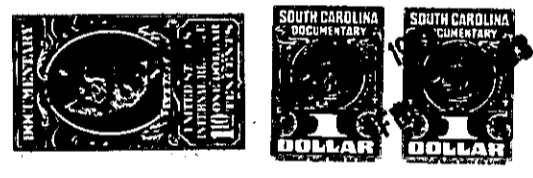

BEGINNING at an iron pin on N. Silver Lake Drive, joint front corners of Lots Nos. 129-A and 130-A, and running thence along the line of said lots, N. 8-12 E. 212 feet to iron pin line of Lot 159; thence running with line of said lot, S. 63-31 E. 90 feet more or less to iron pin on West Silver Lake Drive; thence running with West Silver Lake Drive, S. 8-12 W. 212 feet to iron pin corner of N. Silver Lake Drive and West Silver Lake Drive; thence running with N. Silver Lake Drive, N. 63-31 W. 90.6 feet more or less to iron pin point of beginning.
