ALL that certain piece, parcel or lot of land lying and being on the easterly side of Lake Circle Road on Paris Mountain, near the City of Greenville, S. C., being known and designated as the major portion of Lot 28, Section C, as shown on plat of the property of Paris Mountain-Caesar's Head Development Company (unrecorded), prepared by R. E. Dalton, dated July 1921, and also an additional area to the east of said Lot 28, Section C, shown on a plat made by J. C. Hill, dated November 11, 1948, entitled, "Extension of Parcels 27, 28, 29 and 30, Lake Circle Road, Paris Mountain" (unrecorded), and being more particularly described as follows:

BEGINNING at an iron pin on the easterly side of Lake Circle Road, which pin is located 2540 feet in a northerly direction from the northeasterly corner of the intersection of Lake Circle Road and Altamont Road, said pin also being the joint front corner of Lots 28 and 29, Section C, and running thence along the easterly side of Lake Circle Road S 19-0 E 250 feet to an iron pin, joint front corner of Lots 27 and 28; thence with the joint line of Lots 27 and 28 and beyond N 61-25 E 550 feet to an iron pin; thence N 13-30 W 168 feet to an iron pin, joint corner with property heretofore conveyed by the grantor to the grantee (see Deed Book 605, page 486); thence with the line of the property of the grantee S 68-50 W 200 feet to an iron pin, joint corner of Lots 28 and 29; thence continuing on the same course with the joint line of said lots S 68-50 W 221.3 feet to a point; thence on a line into Lot 28 S 4-42 E 72.9 feet to an iron pin; thence S 85-13 W 17 feet to an iron pin; thence N 4-27 W 67.9 feet to a point in the joint line of Lots 28 and 29; thence along the common line of said lots S 68-50 W 103.7 feet to an iron pin, the point of beginning.

Lot 28, Section C was conveyed to the grantor in Deed Book 295, page 292. The additional area east of Lot 28 is a portion of the property conveyed to the grantor by deed recorded in Deed Book 371, page 191. The small rectangular portion of Lot 28 excluded by this deed was previously conveyed by the grantor to the grantee by the deed in Deed Book 605, page 486.
