

BROWN, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being on the western side of Summit Drive in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a part of Lot No. 8 of the property of C. Douglas Wilson, a plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "AA", at page 97, and having, according to said plat, and to a more recent plat prepared by Dalton & Neves in January of 1960, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots Nos. 7 and 8, which iron pin is 696.5 feet north of the intersection of said Drive and Pinehurst Drive, and running thence with Summit Drive, N. 1-09 E. 78 feet to an iron pin; thence N.89-30 W. 152.2 feet to an iron pin; thence S. I-26 W. 78 feet to an iron pin; thence S. 89-30 E. 152.6 feet to an iron pin at the point of beginning.

The above described property is the same conveyed to me by Thomas J. Ford by Deed dated December 8th, 1961, and recorded in the R. M. C. Office for Greenville County in Deed Book 688 at Page 155.

As part of the consideration for this conveyance, the Grantee assumes and agrees to pay the balance due on the mortgage given by Thomas Ford to C. Douglas Wilson & Co. and recorded in the R. M. C. Office for Greenville County in Mortgage Book 813 at Page 69 the balance now due and owing being \$14,631.69.
