BEGINNING at a point on the western side of Jervey Avenue, formerly Alta Vista Avenue, 105 feet from the intersection of said Jervey Avenue with Laurens Road, at the corner of property now or formerly of Tremarco Corporation, and running thence with the line of property now or formerly of Tremarco Corporation, N. 55-41 W. 131 feet to a point in the line of Lot No. 4; running thence along the line of Lot No. 4, N. 32-09 E. 94 feet, more or less, to the joint rear corner of Lots Nos. 4 and 5; running thence along the rear lines of Lots Nos. 5 and 6, S. 55-26 E. 128.4 feet to a point on the western side of Jervey Avenue; thence with the western side of Jervey Avenue, approximately S. 30-07 W. 93.5 feet to the beginning corner; being the same property conveyed to William C.
