ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, and being known and designated as Lot Number 152 of the Property of Central Development Corporation according to a plat of record in the R. M. C. Office for Greenville County in Plat Book BBat Pages 22-23, and having the following metes and bounds, to wit:
