

ALSO All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Ward Six of the City of Greenville, located at the northeast corner of Nichols and Plum Streets and being described as follows:

BEGINNING at a point at the northeast corner of Nichols and Plum Streets (Plum Street now being known as Means Street) and running thence in an easterly direction with Nichols Street 98 feet, more or less, to a stake; thence in a northern direction 100 feet to a stake; thence in a western direction parallel with Nichols Street 72 feet to a stake; thence with Means Street 103.5 feet, more or less, to the beginning corner; being the same property conveyed to H. BEGINNING at an iron pin on the extension of Hampton Avenue and running thence N. 18 E. 80 feet with Hampton Avenue Extension to iron pin; thence N. 72 W. 156 feet to an iron pin; thence N. 26 W. 131 feet and 10 inches to an iron pin on Michael Street; thence with said street, S. 64 W. 60 feet to an iron pin at the corner of Lot 13; thence with Lot 13, S. 26 E. 146 feet to an iron pin at the corner of Lots 10, 12 and 13; thence with the rear line of Lot 10, N. 64 E. 60 feet to an iron pin corner of Lots 8, 9, 10 and 11; thence along Lots 9 and 10, S. 26 E. 146 feet to an iron pin on St. Clair Street; running thence with St. Clair Street, N. 64 E. 60 feet to the beginning corner; being the same property conveyed to H. The Trustees herein are authorized and specifically instructed to use their best efforts to sell and dispose of all or any part of the above described properties, as soon as practical, for the best available price or prices. Said properties or any portions thereof, may be sold from time to time, either at public or private sale, with or without advertisement, for cash or upon any reasonable terms, and the determination of the best possible sales price shall be left to the sole discretion of the Trustees. The net proceeds resulting from any sale shall be paid to the grantor(s) herein, his (her, their) heirs, successors and assigns in accordance with their interest. No purchaser shall be required to see to the application of the proceeds resulting from any sales.
