All that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, situate, lying and being on the south side of Mount Vista Avenue, being known and designated as Lot No. 190 on revised plat of Traxler Park, made by Dalton & Neves, Engineers, March, 1923, and recorded in the R. M. C. Office for Greenville County in Plat Book "F", at pages 114 and 115, and by plat of property of the grantors herein, prepared by R. W.
