To purchase, sell, rent, lease, develop, subdivide and improve real property within towns, cities and villages and their suburbs not extending more than two miles beyond their limits. To acquire, own, lease and rent, and to seal, lease or rent to others, buildings, improvements, and structures of every kind and description. To acquire, own, lease and rent, and to sell, lease, rent and mortgage to others materials, machinery, equipment, supplies, goods, wares and merchandise of every kind and description. To contract to and to serve as manager, consultant, representative, agent or advisor for other persons, associations, corporations, and firms subject to and upon compliance with all applicable state and federal statutes and regulations. To buy, sell, maintain, and otherwise deal in livestock, and to carry on the business of farming and ranching. (Over)

To establish, maintain and conduct any general sales, services or merchandising business in all its aspects for the purpose of selling, purchasing, licensing, renting, leasing, operating, and otherwise dealing with personal services, trade-marks, trade names, patents, privileges, processes, improvements, copyrights, instruments, machines, appliances, inventions and personal property of every kind and description.

In general to carry on any other business and to do any other acts in connection with the foregoing and to have and exercise all powers conferred by the laws of the State of South Carolina upon corporations formed under the laws of the State of South Carolina, and to do any or all of the things hereinabove set forth to the same extent as natural persons might or could do.
