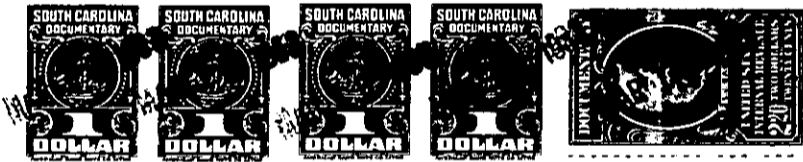
H. Grady Cole, Jr. and Lois F. Cole, their Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the eastern side of Marlboro Drive and being known and designated as Lot No. 262 of Belle Meade, Section 3, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "GG", at Page 187 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Marlboro Drive at the joint front corner of Lots Nos. 262 and 263 and running thence along the joint line of said lots, N. 83-16 E. 140 feet to an iron pin; thence N. 6-44 W. 80 feet to an iron pin; thence along the line of Lot No. 261, S. 83-16 W. 140 feet to an iron pin; thence along Marlboro Drive, S. 6-44 E. 80 feet to the point of beginning.
