to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Clarke Evans, his heirs and assigns forever:

All that certain lot of land in Greenville County, State of South Carolina, lying and being on the southeastern corner of the intersection of Vale Street (also known as Peach Lane) with Jolly Avenue in Paris Mountain Township, near the City of Greenville, being shown as lot # 81 on a plat of White Horse Heights, Section 2, prepared by C. C. Jones, dated May 11, 1955, and recorded in Plat Book BB at Page 183, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the southern side of Jolly Avenue, at the front corner of lot 82, and running thence with the line of said lot, S. 21-13 E. 120 feet to aniron pin at the rear corner of lot 80; thence with the line of said lot, S. 68-47 W. 160 feet to iron pin on the eastern side of Vale Street; thence with the eastern side of said Street, N. 21-13 W. 35.1 feet to an iron pin; thence continuing with the curve of the eastern side of said street, the chord of which is N. 7-45 W. 68-1 feet to an iron pin near the intersection of said street with Jolly Avenue; thence with the curve of said intersection, the chord of which is N. 37-27 E. 35.5 feet to an iron pin on the southern side of Jolly Avenue; thence with the southern side of said avenue, N. 68-47 E. 114.1 feet to the beginning corner. Being the same premises conveyed to the grantors by deed recorded in Book of Deeds 618 at Page 148.

As a part of the consideration for this deed the grantee assumes and agrees to pay balance due on a mortgage held by Western & Southern Life Insurance Co. recorded In Volume 777 at Page 387. The balance due on said mortgage being \$9276.46.
