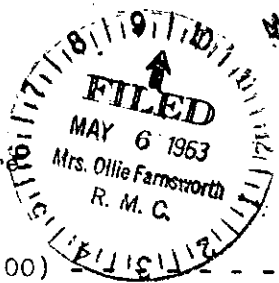

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot no. 166, as shown on a plat of Section No. 1, Caroline Court, dated September 1953 by Dalton & Neves Engineers, recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 44, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Manhattan Boulevard, joint front corners of Lots 165 and 166 and running thence along the line of said lots, N. 25-15 E. 240 feet to iron pin rear corner of Lots 161 and 162; thence running with rear line of Lot 161, S. 64-45 E. 100 feet to iron pin rear corner of Lot 167; thence running with line of said lot S. 25-15 W. 240 feet to iron pin on Manhattan Boulevard; thence running with Manhattan Boulevard, N. 61-45 W. 100 feet to iron pin point of beginning.
