

KNOW ALL MEN BY THESE PRESENTS, that We, Jack A. Watson and Ansel Alewine, of Greenville County,

in consideration of Nineteen Thousand and No/100 - - - - - -

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release H. M. Watson and Hazel Watson, their heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwest side of Elizabeth Drive and on the southeast side of Mabel Avenue, near the City of Greenville, being shown as Lot No. 245 on plat of property of Robert J. Edwards, made by Dalton & Neves, Engineers, May 1951, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book EE, pages 60 and 61, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwest side of Elizabeth Drive at joint corner of Lots 244 and 245, and running thence with the line of Lot 244, S. 56-30 W. 188.4 feet to an iron pin; thence N. 33-30 W. 77.6 feet to an iron pin on the southeast side of Mabel Avenue; thence with the southeast side of Mabel Avenue, N. 43-00 E. 160.3 feet to an iron pin on the southeast side of Mabel Avenue; thence with the curve of Mabel Avenue and Elizabeth Drive (the chord being S. 87-11 E. 32.2 feet) to an iron pin on the southwest side of Elizabeth Drive; thence with Elizabeth Drive, S. 37-40 E. 96.5 feet to the point of beginning; being the same conveyed to Jack A. Watson by MaryPearson Barnes by deed dated February 13, 1959, recorded in R.M.C. Office for Greenville County in Deed Vol. 617, at page 25, the said Jack A. Watson having conveyed an undivided one-half interest to Ansel Alewine by deed dated November 9, 1961, recorded in Deed Vol. 686, Page 272.
