in consideration of Five (\$5.00) Dollars and love and affection

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Norman G. Anderson, his heirs and assigns forever:

All of my right, title, and interest in and to the following described real property, less any portion heretofore conveyed by Mary C. Anderson and the Grantee herein:

ALL that certain piece, parcel or tract of land situate, lying and being in Butler Township, County of Greenville, State of South Carolina, on the branches of Rocky Creek containing 83.40 acres of land as shown on plat thereof prepared by W. J. Riddle, Surveyor, October 23, 1935, and having according to said plat the following metes and bounds, courses and distances, to-wit:

BEGINNING at a poplar on Rocky Creek and running thence S. 6 E. 142 feet to a stone; thence N. 85 E. 69 feet to a stone; thence S. 24-23 E. 1,240 feet to a stake; thence S. 27-45 E. 1,933 feet to an iron pin; thence N. 72 E. 1,010 feet to a stone; thence N. 12-00 W. 2,464 feet to a stake on Rocky Creek; thence with the center of said branch as the line S. 75-45 W. 278 feet to a point; thence S. 71-15 W. 309 feet to a point; thence S. 87 W. 584 feet to a point; thence N. 84-30 W. 220 feet to a point; thence N. 58 W. 456 feet to a point; thence continuing with the center of said branch N. 52 W. 276 feet to a poplar, the beginning corner.

Being the same conveyed to Mary C. Anderson and Norman G. Anderson by Ray Williams by deed recorded in the R. M. C. Office for this County in Deeds Book 438, Page 135. Subsequently, Mary C. Anderson died intestate, leaving as her sole heirs and distributees at law, her children, Margaret Cheves Waller and Janet Cheves Paden, and her husband, Norman G. Anderson, the Grantee herein, and by this deed, the Grantor, Margaret Cheves Waller, intends to convey to the Grantee all her right, title, and interest in the above described property. A similar deed by Janet Cheves Paden is separate and recorded of even date herewith.
