Six Thousand Nine Hundred Fifty and no/100-----Dollars,
the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and
release unto Virginia A. Ford, her heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in the
State of South Carolina, County of Greenville, on the eastern side of Link
Street, now known as Temple Street, near the City of Greenville, being shown
as part of Lot 3 on a plat of property of Looper and Yown recorded in the
R. M. C. Office for Greenville County in Plat Book F, at Page 48, and according
to a later plat prepared by Madison H. Woodward, June 7, 1963, having the
following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Temple Street at the joint
front corner of lots #2 and #3, which iron pin is 27 feet southeast from the
projected corner of Durham Street, and running thence with the joint line of
lot #2, N. 69 E. 132 feet to an iron pin; thence along a new line through
lot #3, S. 21-30 E. 50 feet to an iron pin in the lot line of lot #4; thence
with lot #4, S. 69 W. 132 feet to an iron pin on the eastern side of Temple
Street; thence with the eastern side of said street, N. 21-30 W. 50 feet to
an iron pin, point of beginning.
