All that lot of land in Greenville County, South Carolina, known and designated as Lot No. 10 on plat of James H. and Inez H. Sutton property recorded in plat book JJ page 63 of the RMC Office for Greenville County, S. C., said lot having a frontage of 78 feet on the northwest side of Duncan Road, a depth of 112 feet on the northwest side, a depth of 132 feet on the northeast side and a rear width of 113.3 feet.

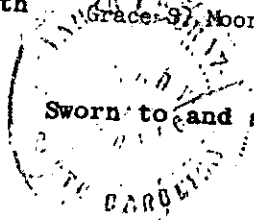
