All that lot of land lying in the State of South Carolina, in Greenville County, in the City of Greenville, on the south side of East Montclair Avenue, formerly known as East Fairview Avenue, shown as Lot No. 4 on a plat of property of Lucy L. Hindman, recorded in the RMC Office for Greenville County in Plat Book T at Page 42 and being further described as follows:
