RELEASE OF EXPIRED LEASE

WHEREAS, on the 19th day of February, 19 52, a certain written lease agreement was made by and between Nannie C. Pinson of Greenville County, South Carolina

WHEREAS, the term of said lease has expired and terminated but the lease has not been released of record.

NOW, THEREFORE, in consideration of the premises, THE PURE OIL COMPANY does hereby agree and declare that it has no further right, title, interest or estate in and under the aforesaid lease agreement, and does hereby authorize and direct the Recorder or Register of Deeds of the aforesaid County and State to release and discharge said lease on the records in his office.

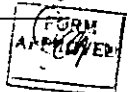
