the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto David Reid Blakely, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, between North Parker Road and Honeysuckle Drive, being known and designated as Lot No. 1 of a subdivision of the property of Susan R. Hawkins as shown on plat thereof prepared by C. C. Jones, C. E., October 12, 1962, revised December 18, 1962, and recorded in the R. M. C.
